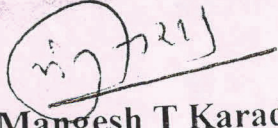

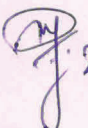

INTERNAL AUDIT OBSERVATIONS
ON MAEER'S Art, Commerce and Science College, Alandi
For the Half Year Ended March 2016

1. A new building is being constructed for the college in Alandi. All the payments made either by college or by the H.O. towards cost of construction are being debited to Building Construction WIP A/c.
An amount of Rs. 5,80,81,762/- has been debited to above a/c in the books of ACSC by credit to H.O. a/c which represents various payments made by H.O. during the year for the ongoing Construction. However individual payment wise details sent by the H.O was not made available to us for our verification.
2. All the provisions entries including Depreciation will be accounted for after finalization of these Accounts by MAEER.
3. We have physically verified cash in hand at the close of 04.05.2016. An amount of Rs. 5,40,618/- was counted which was found to be correct as per the manual Cash Register maintained.
4. All the bank accounts operated by the college were found to be reconciled upto 31.03.2016 with the respective bank statements. We have also examined the Balance Confirmation Certificates obtained from bankers at the year end.
5. Accounts of ACSC – Alandi are duly reconciled with those at H.O. as at 31.03.2016
6. We have observed that difference shows between student ledger a/c and MIT ACSC A/c in Outstanding fees of Academic Year 2015-16 of Rs. 55,300/- In Student ledger it shows balance of Rs. 6,55,680/- and in MIT ACSC A/c it shows balance of Rs. 6,05,380/- as on 31.03.2016. The same shall be reconciled.
7. College recovers Bus Charges from the salary of it's employees who use Bus service provided by college. It is suggested that separate ledger accounts shall be opened for teaching and non-teaching staff as in the case of salary A/c. *pl do the needful*
8. Our findings on Payment Vouching and Receipts Vouching were discussed with the Accounts Dept. and were duly rectified by them.

Note:

The accounts of the ACSC were yet to be finalized at the time of our audit. The amounts mentioned in our above report at various places and the head of accounts have been given on the basis of position of books of accounts at the time of finalization of this report. Some of accounts/heads of accounts are subject to change hereafter at the time of finalization of accounts.



We express our thanks for the co-operation received from the employees of Accounts Dept. of ACSC during the conduct of this audit.

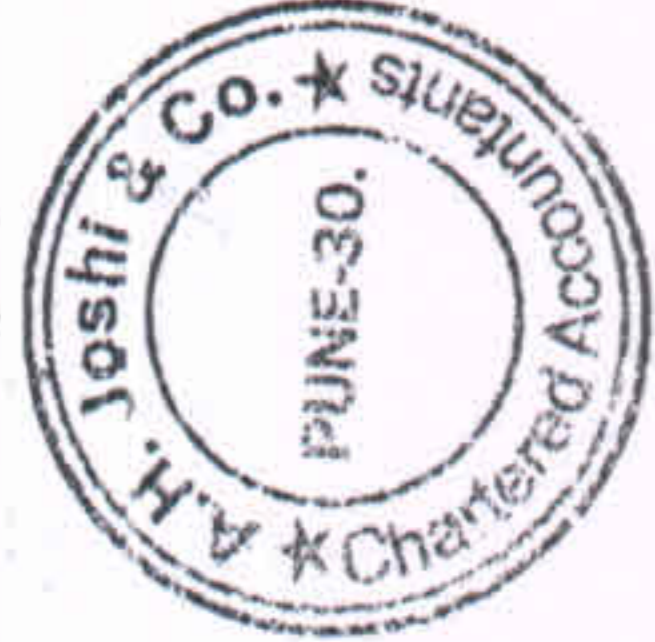
